#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most ingestions cause no symptoms or only mild gastroenteritis. Patients recover quickly with supportive care. Emergency and supportive measures: Maintain an open airway and assist ventilation if necessary. Administer supplemental oxygen. Treat coma, seizures, arrhythmias, and hypotension if they occur. Replace fluid losses caused by gastroenteritis with IV crystalloid solutions. ...

Decontamination: Wash the affected areas with soap and water and give sips of water to drink. Administer ice cream, juice bars, pudding, or cold milk to soothe irritated oral mucous membranes after exposure to insoluble oxalate plants. Do not induce vomiting because of potential aggravation or irritant effects. Activated charcoal is not necessary. Plants

## 12.3 Bioaccumulative potential

An estimated BCF of 47 was calculated in fish for capsaicin(SRC), using a log Kow of 3.04(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate(SRC).

## 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of capsaicin can be estimated to be  $1.2 \times 10^4$ (SRC). According to a classification scheme(2), this estimated Koc value suggests that capsaicin is expected to be immobile in soil.

## 13.1 Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing.

Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
